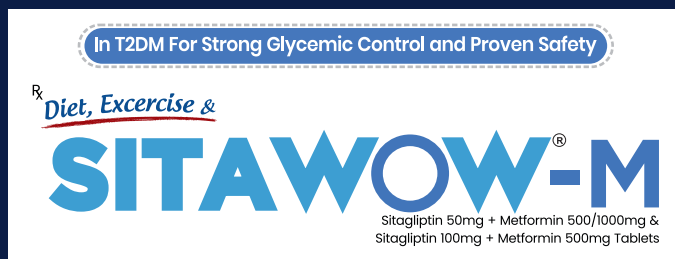
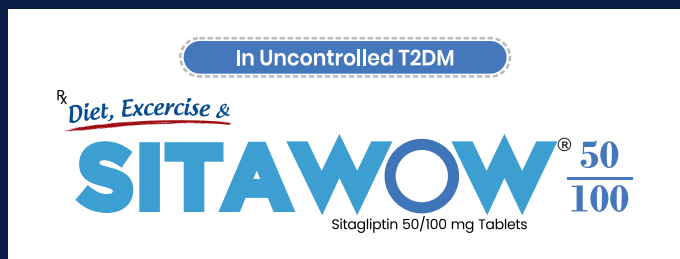

DESCRIPTION:

- ➔ **SITAWOW Tablet** is available in two strengths : Sitagliptin 50 mg and 100 mg.
- ➔ **SITAWOW –M Tablet** is available in two strengths: Sitagliptin 50 mg and 500 mg & Sitagliptin 50 mg and 1000 mg.
- ➔ **SITAWOW –M 100/ 500** is available in one strength: Sitagliptin 100 mg and 500 mg prolonged release tablets.

INDICATIONS:

- ➔ **SITAWOW** : A DPP-4 (dipeptidyl peptidase-4) inhibitor, indicated as an adjunct to diet and exercise In Uncontrolled Type 2 Diabetes.
- ➔ **SITAWOW-M** : Indicated as an adjunct to diet and exercise In T2DM For Strong Glycemic Control and Proven Safety.

MECHANISM OF ACTION:

- ➔ **Sitagliptin**: Selectively inhibits DPP-4, the enzyme responsible for degrading incretin hormones, thereby enhancing glucose-dependent insulin secretion and regulating post-meal blood sugar.
- ➔ **Metformin**: Lowers blood glucose by reducing hepatic glucose production, decreasing intestinal glucose absorption, and improving insulin sensitivity for enhanced peripheral glucose utilization.

DOSAGE & ADMINISTRATION:

- ➔ **SITAWOW**: Recommended dose is 100 mg once daily or as directed by a doctor.
- ➔ **Dose adjustments for moderate to severe renal impairment:**
eGFR 30–45 ml/min: 50 mg once daily
eGFR <30 ml/min or on dialysis: 25 mg once daily is recommended

SITAWOW-M:

- ➔ For patients on Metformin 500 mg twice daily: start with 50/500 mg, 1 tablet twice daily or as directed by a doctor.
- ➔ For patients on Metformin 1000 mg twice daily: start with 50/1000 mg, 1 tablet twice daily or as directed by a doctor.

SITAWOW-M 100/500 PROLONGED RELEASE:

- ➔ Recommended dose for 100 mg Sitagliptin with 500 mg Metformin is once daily or as directed by a doctor.
